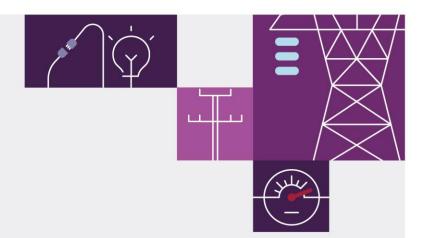

1 Introduction

1.1 Overview

These are the release notes for the WEMDEUI 2.2 release. This WEMDEUI release includes v2 dispatchCase and dispatchSolution endpoints, Network Operator procured NCESS endpoint, as well as several quality of life and bug fix changes.

The changes introduced in this release are described in the sections below.

2 dispatchCase and dispatchSolution v2 APIs [WEMDEUI-80, WEMDEUI-82]

The WEM Dispatch v2 APIs extend the functionality of the v1 collections below with heightened metadata, increased situational awareness of Affected/Missing Dispatch Intervals and uniformity across case/solution request parameters/responses:

- Dispatch Case
- Dispatch Solution

AEMO intend to retire/deprecate the v1 functionality for Dispatch Case and Dispatch Solution APIs around June 2025.

3 Network Operator procured NCESS API [WEMDEUI-11]

Under section 5.9.2 of the WEM Rules, AEMO are required to provide Network Operators with details of any quantities dispatched or otherwise instructed by AEMO to be provided under their NCESS Contracts in a Trading Week by 5:00 PM on the Invoicing Date for Settlement Statements for that Trading Week.

This data is currently provided by email, but with the introduction of WEMDEUI-11, the data can be retrieved by the Network Operator using a new API Endpoint which will include the information required under section 5.9.3 of the WEM Rules.
